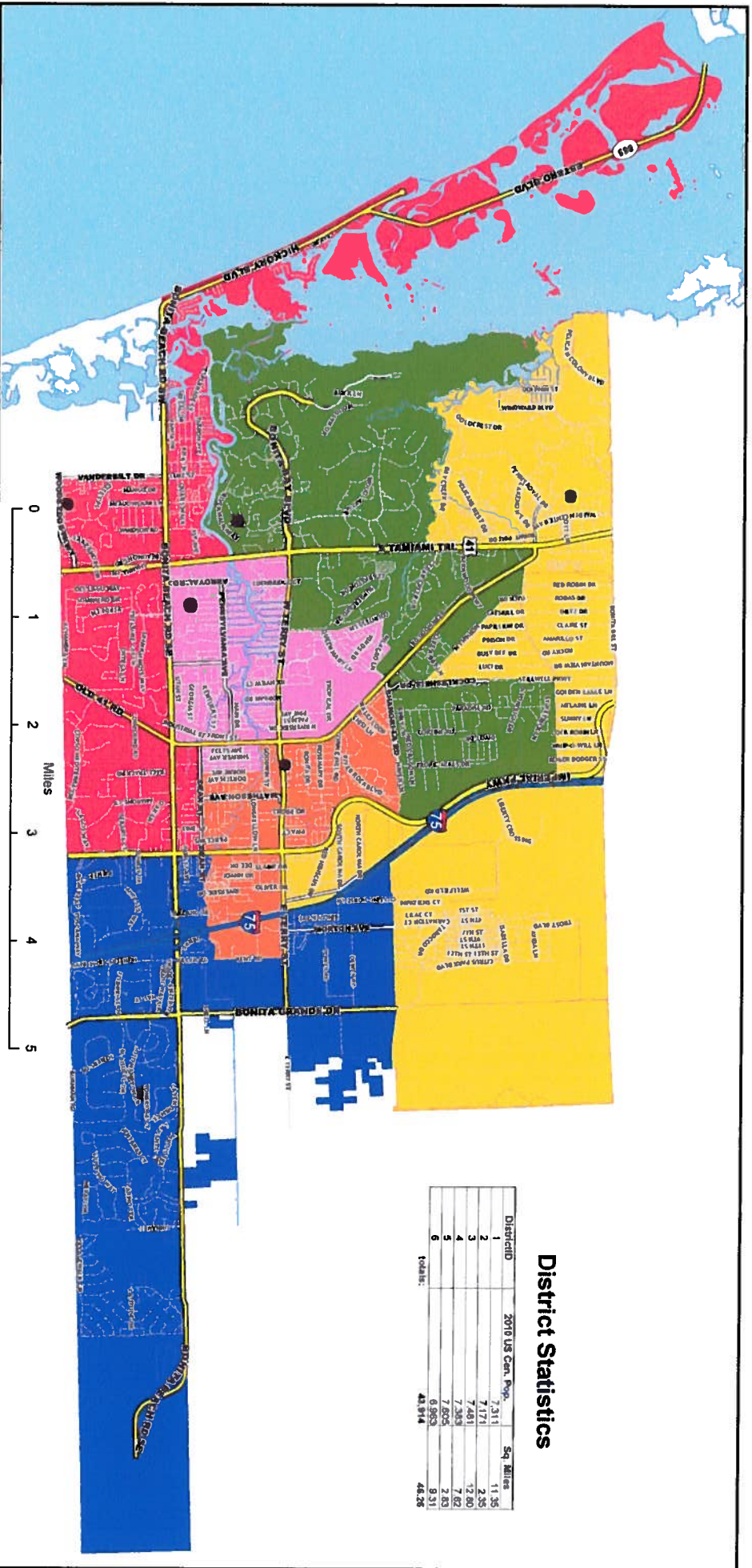
Mayor and Council:
