Did you know that sparklers burn at over 1000 degrees? That's enough to melt gold.... and little fingers. Even seemingly safe fireworks can cause severe injuries if not used safely.



## Keep the Sparks in the Sky this Fourth of July



According to the National Fire Protection Association, in 2011 fireworks caused an estimated 17,800 reported fires. These fires resulted in an estimated eight civilian deaths, 40 civilian injuries and \$32 million in direct property damage. U.S. hospital emergency rooms treated an estimated 9,600 people for firework-related injuries. Injuries are most commonly treated as burns to all body parts as well as contusions and lacerations to the head, eyes and ears. The risk of fireworks injury is highest for children ages five to nine and adults ages 25 to 44.

**There is no doubt that fireworks are breathtaking, but the Bonita Springs Fire Control and Rescue District would like to remind you that each July Fourth, thousands of people are injured each year while using fireworks.**

Bonita Springs Fire Department's primary message this July season is to leave fireworks up to the professionals! However, if you are planning on purchasing fireworks, please make sure to take these precautions:

- Remove all flammables within 10—15 feet around the designated area.
- Establish a well defined space into which only ONE person will enter to set up and light the fireworks.
- Children should not handle, play with, or light fireworks for any reason.
- Approach a firework after 45-60 seconds has passed since its last activity to ensure it is out.
- Keep a bucket of water or a hose within reach and make sure the hose is long enough to reach 10 ft. beyond the fireworks.
- Always discharge fireworks outside. After lit, move away slowly to avoid tripping and falling.
- Verify the firework is 100% cold before placing in trash.
- Never relight a dud; if a firework fails to make any action, wait 5 minutes before removing it.



It is always safer to leave fireworks to the professionals! Bonita Springs annual Star Spangled Bonita Party in the Park Event begins at Riverside Park at 5:00 p.m. Fireworks and an amazing light show will begin after dark. Bring your friends and relatives for a fun filled old fashioned summer celebration!

# GET INFORMED LEE COUNTY

**Did you know that flood zones are not the same as Evacuation Zones? Flood zones are determined by FEMA and influence insurance matters. Evacuation zones assess risk based upon storm surge and wind and determine how evacuations will proceed.**

## FEMA Flood Zone Designations

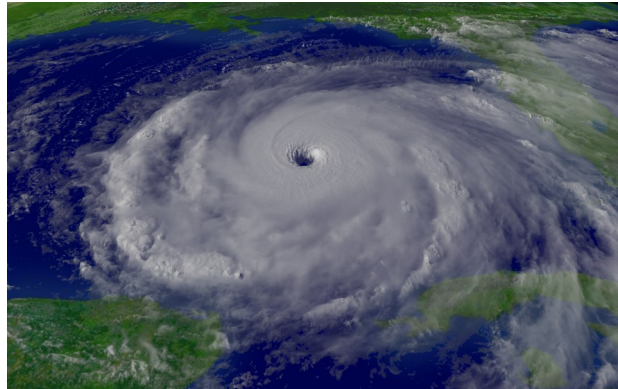
Flood zones are areas mapped by FEMA (Federal Emergency Management Association) for use in the National Flood Insurance Program. Each flood zone designation, represented by a letter or letters, tells homeowners their risk for flooding on their property. Homes with a mortgage located in high risk areas must have flood insurance.

You will use the search icon to type in your address. Labels are provided on the map to describe which flood zone each property lies within. Properties shown in red are VE zones, while properties in blue are AE zones. Please note, if your property lies within 2 or more flood zones, the more restrictive applies. VE is more restrictive than AE, and a higher number is more restrictive than a lower number.



Evacuation zones are based on storm surge zones determined by the National Hurricane Center. Lee County and Bonita Springs use the letters A–E to identify evacuation zones based on the areas that are likely to be affected by storm surge. A home may be located in a non-evacuation zone but still be located in a flood zone because of a nearby water body.

## **BONITA SPRINGS STORM SEASON UPDATE**

The City of Bonita Springs has been actively preparing for the upcoming storm season over the last several months. Although the city continues to complete projects post IRMA, the damage was extensive and there is still more work to be done. It is a priority for the city to continue to work to remove Irma related debris and continue working on repairs. The city is pursuing additional funding resources for these projects. As funding resources become available, the city continues to prioritize clearing conveyances and making repairs. Partnerships with agencies like the Department of Environmental Protection, South Florida Water Management District, Lee County and the Federal Emergency Management Agency are needed to complete projects and assist with funding.

Efforts to keep you informed are ongoing. Below you will find a list that includes examples of work being done. Please note that this isn't a comprehensive list of all work.

### **Immediately following Irma, the city of Bonita Springs**

- Coordinated removal of 523,891 cubic yards of debris in the city;
- retained the South West Florida Regional Planning Council to conduct the Flood Reduction Study;
- prioritized communication to our residents regarding damage, clean up and available resources;
- replaced and repaired damaged street signs; and
- City Council convened weekly to work on Irma related projects to ensure an expedited recovery process and that the study was initiated in a timely manner to pursue an expedited long term recovery process.

### **Repairs since the storm**

- repaired sidewalks damaged by utility trucks;
- repaired storm water retention pond inlet structures citywide;
- restored the Luke Street road failure, culvert and road damage on Imperial Harbor Blvd. entrance for Old 41 and the East Terry Street shoulder. Re-established and regraded East Terry St. swale, coordinated swale restoration with FDOT and I-75 right away. Regraded Southern Pines Dr. swale system;
- regraded Circle Dr. swale system, cleared flow way along Pine Trail Ct.;
- cleared flow way along Pine Crest Ln.;
- snag and clearing to the Imperial River, Kehl Canal, Lietner Creek Canal and bypass, Rosemary Canal;
- applied for grant funding to USDA to snag & clear Leitner Creek. The City has received notice of award for grant funding from the U.S. Department of Agriculture via the Natural Resources Conservation Service's Emergency Watershed Program in April. Developed bid package for snagging and clearing project along the natural portion of Leitner Creek for the summer.

### **Financial Impact**

- Total expenses for the storm paid so far are approximately \$7.7 million. (There still are repairs from hurricane damage that need to be completed.); and
- staff continues to submit information to FEMA relating to the damages. We are awaiting approval of funding.

### **Ongoing Resolution**

- The City is working with the South Florida Water Mgmt. District to snag and clear Oak Creek. Meetings were held in May to discuss logistics and project details. Recently, the South Florida Water Management District committed to clearing debris in Oak Creek;
- worked with the South Florida Water Mgmt. District to model regional flow way along the Logan Blvd. Rd. corridor to re-establish historical storm water flow patterns sending water into the Cocohatchee and thereby removing it from the Imperial River Watershed;
- continue to coordinate efforts with Lee County Natural Resources and their concurrent Flood Recovery and Assessment efforts;

- incorporated components of Logan Blvd. flow way into Logan Blvd. Roadway design for construction in the upcoming year;
- the South Florida Water Management District is working to permit and construct a North/South flow-way, in addition to Logan Blvd. flow-way, in Eastern Bonita to re-establish additional flows in the Cocohatchee;
- City Council reaffirmed at a recent workshop that the number one priority for the city is Storm Water Management;
- City Council has solicited letters of interest for firms to assist the city in the establishment of a storm water utility/fee funding mechanism to pay for additional storm water infrastructure improvement projects. Subsequently a firm was selected and contract negotiations are underway;
- working with the Lee County Local Mitigation Strategy Committee to prioritize projects that were identified in the city's flood reduction study for funding through FEMA's Hazard Mitigation Grant Program;
- retained a Federal Funding Consultant to assist the city in its pursuit of additional funding opportunities as they become available; and
- working with Lee County's Multijurisdictional Program for public information about Flood Hazard and Flood Insurance Rate Maps.

## **Community**

- EOC Long Term Recovery Committee continues to work with those with the most extreme challenges and worst difficulties as a result of the storm;
- April 26th community hurricane preparedness event held at Bonita Springs Recreation Center; and
- continue to update email list for contact with community representatives.

## **Training**

- Municipal Emergency Preparedness training exercises;
- FEMA Incident Command Training; and
- Everbridge Software Training

## **Storm Preparation**

- Emergency Preparedness messaging shared on all city media;
- city media supports the Emergency Operations Center messaging;
- updating and disseminating the City's Emergency Action Plan;
- desilting storm water piping throughout the city;
- continue to monitor weather and inspect the storm water system;
- continue to share storm preparation information from the Lee County Emergency Management Center; and
- continue to share public information regarding preparation for flood events and information that residents can use to protect themselves with insurance in a flood event. For example: One tip we are sharing from insurance experts is that residents should closely review their flood insurance policy to be sure it covers both structure and contents. Content coverage may not be included your policy. Residents are encouraged to contact their flood insurance agent with questions.

As we enter another storm season much work has been completed and there is also more to be done. This list will be updated as warranted. ## MAKE SURE TO USE LICENSED CONTRACTORS!

**As some of you may still be in the recovery phase of hurricane Irma please watch for red flags that you may be dealing with an unlicensed contractor.**

1. **No license number in advertisement or posting.** Licensed contractors are required to list their license number in all advertisements. Rule of thumb: Do not do hire anyone that does not have a license listed in their advertisement that can be verified. Verify state licenses by checking [www.myfloridalicense.com](http://www.myfloridalicense.com) or verify a local competency card for painting, tile, finish carpentry (wood flooring), cabinetry, fence erection ext, by calling Lee County Contractor Licensing (239) 533-5895 or [www.leegov.com](http://www.leegov.com)
2. **Advertisement or invoice lists only a name and telephone number.** A legitimate business provides sufficient contact and licensure information on an invoice.
3. **A claim to be “licensed and insured” but cannot produce a DBPR issued license or competency card issued by Lee County** This type of claim often merely means that the person has a driver’s license and automobile insurance.
4. **Want all or most of the money up front or will only accept cash.** Never pay cash for your home repairs or improvements.
5. **Want check written to them individually or to “cash.”** Be cautious of writing checks payable to individuals when a company has contracted to do the work. Include a note on check or money order about what the payment is for.
6. **Blank or generic invoice.** Contractors licensed are required to display their license number on an invoice.
7. **Oral agreement only.** The best business practice is to put everything in writing, including a detailed description of the work to be completed, an anticipated completion date and the total cost.
8. **Ask you to pull the permit.** Pulling an Owner-Builder permit is risky business. Licensed contractors must pull the permit themselves and unlicensed contractors are unable to pull permits.
9. **Unsolicited phone calls or visits.** Some reputable contractors do business this way, but it is generally a tactic of the unlicensed. Be very wary of anyone who offers a bargain price, saying they are doing a job in the neighborhood and have leftover materials.
10. **High pressure sales pitches or scare tactics.** Don’t be pushed into hiring anyone, even during a state of emergency! Dishonest people will prey on your fears.

## Please remember

## Sea Turtle Nesting Season Guidelines

- **Shut off or shield lights that are visible from the beach. Close drapes or blinds after dark.** Use 25 watt yellow-bug lights where exterior lighting is necessary. Avoid using flashlights or fishing lanterns on the beach. Fires are not permitted. Lee County has a **Sea Turtle Conservation Code** which is enforced. For information regarding lighting, or to report a lighting violation, please call Lee County Division of Environmental Sciences (239) 533-8353.
- **Remove beach litter.** Balloons, plastic bags, foam and other non-degradable pollutants cause the deaths of many sea turtles who mistake them for food.
- **Quietly observe a nesting turtle from a distance.** Do not shine any lights on or around her, she may abandon her effort to nest. No flash photography. Stay behind the turtle so that she cannot see you.
- **Do not harass a turtle** by touching her or prodding her to move. Stay out of the way as she crawls back to the water.
- **Stack or remove beach furniture.**
- **Keep pets on a leash,** away from sea turtles and their nests.
- **Leave sea turtle nest identification markers** in place on the beach.
- **Leave nest sites undisturbed.** If you find a hatchling wandering in daylight, place it on moist sand in a dry container, shade it and call Turtle Time, Inc. immediately: 239-481-5566.

- ◆ *Mayor Simmons recently wrote a letter to Congressman Rooney in support of H.R. 4770 to permanently extend the moratorium on off-shore drilling in the Eastern Gulf of Mexico.*
- ◆ *The City of Bonita Springs entered into an agreement with Seminole Gulf Railroad permitting the City the use of railroad right-of-way for roadway crossings within the city. This agreement identifies the city as being responsible for the maintenance and improvement of the rail crossings. Furthermore, the Seminole Gulf Railway L.P. is identified as responsible for the design and construction of crossing improvements.*
