COMMITTEE SPOTLIGHT:

The Historic Preservation Board

Preservation The Historic Board was established by ordinance as part of the Land Development Code for the purpose of identifying, evaluating, preserving and protecting historical and archaeological sites and districts, as well as to promote the cultural, health, moral, economic, educational, aesthetic and general welfare of the public. The Board consists of seven volunteer advisory board members that are appointed by City Council on the basis of a potential member's civic pride, involvement in community issues, integrity, experience and interest in the field of historic preservation.

The Board is vested with the power, authority, and jurisdiction to designate, regulate and administer historical, cultural, archaeological and architectural resources within the City. These actions allow the City to maintain its status as a Certified Local Government under the National Historic Preservation Act, which allows the City access to additional funding, technical assistance, and many other economic, environmental and social benefits. Maintaining this status demonstrates our community's commitment to saving what is important from the past for future generations.

The Board encourages historic preservation by creating and administering programs of technical assistance and financial incentives for preservation practices in order to stabilize and improve property values through the revitalization of older residential and commercial neighborhoods. They also promote historic preservation activities and cultural and educational programs aimed at fostering a better understanding of the community's heritage.



DID YOU KNOW... that the City's Historic Preservation Board offers **GRANT MONEY** that may be used for repairs, restoration, or rehabilitation of any designated historic property within the City?

A designated historic resource is a building or structure that has been recognized by the historic preservation board as possessing historical, architectural, cultural or archaeological value. Designated historic resources and contributing properties may be eligible for administrative variances, or other forms of relief, from:

- technical requirements of the Florida Building Code
- **City zoning regulations** such as setbacks, lot width, parking requirements, etc.
- Flood plain management regulations

There are many ways in which a home or property could qualify to become a designated historic resource. For more information, please contact City Hall or attend any of the Historic Preservation Board meetings to find out whether your home may qualify.

The Historic Preservation Board's meetings are open to the public and are regularly scheduled for **5:30 pm on the fourth Thursday of each month in Room 118 at City Hall**. Please visit the City's website to check for any City calendar updates.





Did You Know.....

Rebuild Florida Infrastructure Repair Program Grant— The Florida Department of Economic Opportunity's (DEO) Grant is being offered to fund restoration and improvement projects in communities most impacted by Hurricane Irma. Application for funding can include creation, restoration, demolition and economic revitalization for areas that are still vulnerable after Irma. The City is applying for this infrastructure grant and hopes to be able to focus on the Quinn/Downs Street area with any grant awards received.

Public Works has been very busy with drainage operations and repairs in preparation for storm season. Stormwater inspections have been completed on 757 inlets, 1,023 pipes and 107 ponds. Thirty-three inlet/ junction boxes have been replaced, 17 dry-retention ponds have been maintained, 27 miles of ditches and swales have been sprayed, mowed, reconstructed or replaced and two miles of pipe have been repaired or replaced.



Everglades Restoration Funding - The Southwest Florida Mayors Resolution supporting \$200 million for Everglades Restoration Funding was adopted by the The US House of Representatives as part of the 2020 Energy and Water Appropriations bill. Mayor Simmons and mayors from surrounding southwest Florida communities have championed this cause and were instrumental in bringing it to the US Conference of Mayors 87th Annual Conference this year to seek nationwide support for the restoration plan.

A comprehensive Everglades restoration plan was passed in 2000; however, annual funding has fallen short. The new bill will go before the senate next and then on to the president for signature. Fingers crossed it receives senate support!



West Terry Street Multi-Use Path Project -Project plans are complete and the project is out to bid. This will be a twelve foot non-motorized multi-use path, with a five foot separated bike lane. Construction is anticipated to begin this fall. See rendering to the left.

Logan Boulevard Project—pictures below. Logan Boulevard will connect Lee and Collier counties north and south, east of I-75 at Bonita Beach Road. Construction is underway. The Roundabout has been poured and landscape planning is nearly complete. Estimated completion date is February 2020.







Voluntary Home Buy Out

The City is submitting a grant application to the Florida Department of Economic Opportunity (FDEO) for a Voluntary Buyout Program. The program is open to all property owners within a flood prone area. The City is concentrating on an area bound on the north by Imperial River, the east by Interstate 75, the south by Bonita Beach Road and the west by Lime Street. The funds are tied to Hurricane Irma funding allocated from the U.S. Department of Housing and Urban Development (HUD). Staff held three public workshops, canvassed the neighborhood and held a public hearing to discuss the program specifics. The City currently has approximately 70 interested property owners willing to participate in the program. The grant application is due to FDEO on October 1st.
