Mike Fiigon with Community Development gave a brief introduction. In response to Board Member Gambrell request for clarification, Mr. Fiigon stated that the Group 1 activity group was permitted by right, and Groups 2 and 3 require the special exception.

Wayne Arnold, AICP with Q. Grady Minor & Assoc. for the Applicant, furnished a presentation of the Applicant's request for the subject property, which is a former warehouse located at 10915 Enterprise Ave. Mr. Arnold stated that the Applicant's intent is for manufacturing with no retail sales and that the Applicant supports staff's recommendations.

Board Member Hershenson inquired about the number of parking spaces. Mr. Arnold stated they would be used by vendors and employees.

Chairman Rascio asked what the changed condition is since the property is vacant.

Mr. Arnold stated the property has been used for warehousing, and the Applicant needs a manufacturing use. He deferred to the City Attorney.

City Attorney Rooney addressed by explaining the difference between a consideration and a finding. Discussion ensued.

Board Member Hershenson made a motion to approve the request, which was seconded by Chairman Rascio.
