II. UPDATE ON THE INSTALLATION OF LYMAN WHITAKER THIRD ART PIECE PROJECTED DELIVERY DATE FROM RENEE TAYLOR GALLERY.

Mr. Jaccarino reported that when the third piece is delivered, it will be held at the maintenance shop on Pine Avenue. Mr. Fullick confirmed that they are going to send pictures to the artist to get his perspective on the best place for the sculpture. Mr. Fullick asked if Ms. Bridges could look at the sculptures and make a recommendation where the third sculpture should go.

The Board discussed the safety of the sculptures at the River Park and the fact that vehicles drive around the park at all hours. Mr. Jaccarino advised that they do have a security camera and the sheriff's office regularly patrols the park. The Board discussed the possibility of a security system with the artwork going into River Park.

Mr. Fullick asked for a motion to ask the City to look into or provide some sort of restrictive barrier between dusk and dawn to protect the artwork, Ms. Bridges so moved, Ms. Flanders seconded, all in favor, motion passed unanimously.

III. DISCUSSION OF THE PREFERRED LOCATION WITHIN RIVER PARK FOR THE UNIVERSITY OF MONTEVALLO EXHIBIT AND COST OF CONCRETE PADS FOR THE INSTALLATION OF THE ART PIECES

The Board discussed the location and placement of the concrete slabs for the sculptures. Mr. Jaccarino recommended staying away from the entrance area where there is a steep berm. Mr. Jaccarino pointed out the flat areas. Ms. Hauserman called her contact at Montevallo and asked if they could send pictures and dimensions of the sculptures tomorrow so the Board can determine placement.

Mr. Jaccarino will call Mses. Flanders, Hauserman and Bridges when he hears from the company who will be pouring the slabs about when they will be at the Park.
