II. DISCUSSION OF VACANCY OF ONE ART IN PUBLIC PLACES BOARD MEMBER

The Board discussed the two candidates for Board positions, Ms. Lori Patton and Mr. David Martin. Ms. Melissa Layner, principal of the Bonita Springs Middle Center for the Arts is also interested in being on the Board, but has not submitted her application yet.

Mr. Fullick opened the discussion to petition City Council for two more positions on the Board. Ms. Perino advised it will take a couple of meetings to change the ordinance to add two additional members.

Ms. Jennifer Perry recommended Lori Patton, Ms. Susan Bridges seconded, 3 ayes, and 3 dissenting nays. Motion tied and did not pass.

Ms. Joanie Licitra made a motion for Mr. Martin, Ms. Flanders seconded, 4 ayes and 2 dissenting nays. Motion passed to add Mr. Martin to the Art in Public Places Board.

*Note: the Board liked both candidates but currently only has a position for one. The Board decided to add one member now and petition Council for 4 new Board positions with the hope to add Ms. Patton once the 4 new positions are created.* 

Ms. Bridges made a motion to increase the Board numbers by 4 positions, Ms. Hauserman seconded; motion passed unanimously.

# III. DISCUSSION OF PURCHASING A NEW PERMANENT PUBLIC ART PIECE OR EXHIBIT

# LYMAN WHITAKER

The Board discussed Mr. Whitaker's sculptures and which pieces would work best for the City.

- The sculptures are kinetic
- The sculptures would attract attention

- The sculptures are affordable
- The sculptures are commercial grade and wind rated

Ms. Perino advised the sculptures would have to be ordered and installed by September 30, 2018 to be paid out of this fiscal year's budget.

Mr. Fullick asked for a motion to buy the 3 sculptures.

Ms. Hauserman moved that the Board pursue a cost estimate with the artist, Lyman Whitaker, to purchase three sculptures titled "Double Spinner", size extra huge approximately 19 feet high, (230"Hx88"Wx90"Hx88"W) 19Ft size, Ms. Perry seconded, motion passed unanimously.



Ms. Flanders asked Mr. Fullick to find out what the difference is between the 19 foot and the 16 foot. Ms. Perino believes it has to do with the wind rating.

Ms. Perino will target the August 1 City council meeting to get it approved.

Mr. Fullick reached out to Mr. Rogers. Mr. Rogers is also interested and has several pieces, but has not sent Mr. Fullick the information he requested. Mr. Fullick recommended tabling this till next year.

## IV. DISCUSSION OF DATES IN AUGUST FOR MURAL RIBBON CUTTING CEREMONEY

The artist was not available to attend the next council meeting on July 18, 2018. The artist and the building owner are available every Monday in August. The Board tentatively selected Monday, August 6 at 9:30 a.m. for the ceremony. Ms. Perino will contact artist and building owner to schedule.

V. BOARD AND STAFF ITEMS

## **Bonita Springs Center for the Arts Exhibition**

Ms. Bridges asked if the City was going to move forward on a group exhibition or is it okay for the Bonita Springs Center for the Arts to go ahead and move forward with their program. Mr. Fullick asked when they were thinking of doing it. Ms. Bridges said it would depend on the artist's availability, but they were hoping for high season. The Board agreed this was a good way to proceed, the Center of the Arts will contact Mr. Whitaker for an exhibition and Mr. Fullick will contact the artist to negotiate a price for the three sculptures.

#### Fiscal Year 2018/2019 Budget

Ms. Perino stated in terms of next fiscal year's budget, everything was submitted. Ms. Perino said the amount is the same as last year. Ms. Perino invited the Board members to come and speak at the budget workshop at 9 a.m. Monday July 16.

#### **Exploring student art exhibitions and internships**

Ms. Hauserman met with a representative of her graduate school, the University of Montevallo in Alabama. They discussed an art piece, *The Becoming*, which shows the relationship of knowledge going from the professor to the student. Ms. Hauserman explained the University has a huge outdoor sculpture program for the students. *The Becoming* was forged on campus by the students and the professor. The University has a forge onsite and they have one on the Birmingham campus. Ms. Hauserman has been in touch with the head of the art department and he would be very interested in pursuing a student exhibition of outdoor sculptures in Bonita Springs. As well, Ms. Hauserman is going to contact the Bonita Springs Center for the Arts to inquire about internships for the students.

Mr. Fullick thinks it would be a wonderful exhibit to do in season and suggested it could be part of the Board's budget next year. Mr. Fullick suggested getting sponsorships to fund the exhibit as well as cover the cost of getting the pieces to Bonita Springs. The Board discussed getting art students involved in exhibitions.

## Locations to Display Art

The Board discussed locations for sculptures. Councilwoman Quaremba suggested DPZ, the design company working on the design for the downtown area, and suggested it might be worth getting in touch with those people when they are doing their conceptual work for downtown. They may have ideas of where the Board could place art. Ms. Perino said DPZ will be meeting with this board to discuss entry pieces so that would be a good time to discuss artwork.
