III. DISCUSSION MURAL LOI 17-002

Arleen opened the discussion introducing Mr. Jarret Stinchcomb as the selected artist for the Letter of Interest (LOI 17-002) to do the mural. Ms. Hunter explained that the City has been in talks with the property owners regarding a mural. The owners have received a façade renovation grant that they are working through and as part of the grant are working with the city architect, Mr. Sam Vincent. The City has worked with the owners and the building is going to stay a right-of-way and be visible with access to the sidewalks. The owners are installing two new 3 x 6 feet windows on the side of the building. There is an existing smaller window which will remain. The mural will have to be designed to work with/around the windows.

Ms. Dyes explained that their business is in-home healthcare for seniors. The office is for clerical and office space. Ms. Dyes loves the old Florida/tropical look and likes beachy/teal colors. They have been permitted for a pergola which will be in the teal color.

Mr. Stinchcomb said he can definitely do old Florida and asked about specific historic influences in the Bonita Springs area. The Board recommended visiting the Liles Hotel and the Bonita Springs Historical Society for inspiration. Ms. Jennifer Perry explained that Bonita was originally called Survey and was situated along the Imperial River.

Mr. Fullick recommended that the owners, city Architect and artist should visit the Liles hotel. They have some great photographs. Ms. Hunter said she could put Mr. Stinchcomb in touch with Mr. Charlie Strader or Ms. Bonnie Whittmore who is the President of the Bonita Springs Historical Society.

Ms. Licitra stated that the owners, the City architect and the artist need to get together and come back to the board with some ideas. Mr. Fullick explained that the Board's job is to tell the owner what's appropriate and then once the owner makes a decision, it goes before City Council with

the endorsement that the Art in Public Places Board has reviewed the design and found it appropriate. The creative decision is between the artist and the owner.

The Board invited Ms. Dyer and Mr. Stinchcomb back to the May meeting to review their ideas.
