ORDINANCE NO. 17-03

AN AMENDMENT TO THE BONITA SPRINGS LAND DEVELOPMENT CODE CHAPTERS 2 (ADMINISTRATION) AND 4 (ZONING); AMENDING §2-467 RELATED TO HURRICANE PREPAREDNESS PERTAINING TO HEALTH CARE FACILITIES; AMENDING §4-408 USE ACTIVITY GROUPS; AMENDING THE APPLICABLE DISTRICT REGULATIONS TO REFLECT USE ACTIVITY GROUP CHANGES IN THE ASSOCIATED ZONING DISTRICT TABLES (TABLES 4-436, 4-488, 4-520, 4-555, 4-613, 4-634, 4-661, 4-685, 4-718, AND 4-740); AMENDING §4-2014 MINIMUM REQUIRED SETBACKS RELATING TO USE ACTIVITY GROUP CHANGES; PROVIDING FOR CONFLICTS OF LAW, SEVERABILITY, CODIFICATION, SCRIVENER'S ERRORS, INCLUSION IN CODE AND AN EFFECTIVE DATE.

WHEREAS, the City of Bonita Springs, Florida is the governing body of Bonita Springs; and

WHEREAS, Florida Statutes §166.021 authorizes the City of Bonita Springs to establish, coordinate and enforce laws that are necessary for the protection of the public; and

WHEREAS, consistent with City of Bonita Springs Charter §72 (a), transitional land development regulations, Bonita Springs until it adopts its own ordinance is to use the land development regulations of Lee County, as the same exists on the date the city commences corporate existence, shall remain in effect as the city's transitional land development regulations; and

WHEREAS, City Council did adopt Ordinance No. 11-02, which adopted the Lee County land development regulations as its own, but did not make many substantive changes; and

WHEREAS, City Council directed staff to review the use activity groups in Chapter 4 and update them accordingly, to ensure the City maintains clear, concise, enforceable development regulations that guide the use of all lands within the City, and that upholds the vision for development set forth in the Bonita Springs Comprehensive Plan; and

WHEREAS, Council has determined that updates to the use activity groups are appropriate to classify new and emerging uses, remove antiquated uses from the Land Development Code, streamline lengthy use group listings, and ensure the use groups appropriately separate more intensive uses from less intensive uses in order to protect public health, safety and welfare.

THE CITY OF BONITA SPRINGS HEREBY ORDAINS:

SECTION ONE: AMENDMENTS TO BONITA SPRINGS LAND DEVELOPMENT CODE CHAPTERS 2 AND 4

Sections 2-467, Hurricane Preparedness pertaining to Health Care Facilities, §4-408 Use Activity Groups; Article V-District Regulations to reflect Use Activity Group Changes in the associated Zoning District Tables (Table 4-436, Table 4-488, Table 4-520, Table 4-555, Table 4-613, Table 4-634, Table 4-661, Table 4-685, Table 4-718, and Table 4-740); §4-2014 Minimum Required Setbacks relating to Use Activity Group Changes, of the Bonita Springs Land Development Code is hereby amended to read as follows, with strike-through identifying deleted language and underline identifying additional language:

BONITA SPRINGS LAND DEVELOPMENT CODE CHAPTER 2

ARTICLE X. - HURRICANE PREPAREDNESS

Sec. 2-467. - Applicability.

This article applies only to development required to obtain a development order under chapter 3 and is applicable to all new residential development within the city that is located in a landfalling Category 1, 2, or 3 storm surge area. This article also applies to new and existing developments of regional impact. The provisions of this article supersede the County Administrative Code Section 7-9 in the event of a conflict. Under this article, residential development includes, but is not limited to, all assisted living facilities, dwelling units, living and housing units, mobile homes, recreational vehicle developments (including recreational vehicles qualifying as permanent residences under this Code), hotel and motel, health care facilities Groups I, II, IV, V and social services facilities Groups IV and V, as these terms are defined in chapter 4. This article does not eliminate the shelter requirements applicable to mobile home or recreational vehicle developments contained in section 3-265 to the extent this obligation is fulfilled by compliance with this article.

BONITA SPRINGS LAND DEVELOPMENT CODE CHAPTER 4

ARTICLE V. - DISTRICT REGULATIONS

Sec. 4-408. - Use activity groups.

- (a) Purpose and intent. The purpose and intent of this section is to provide a method whereby lengthy lists of use activities can be categorized into simplified groups for insertion and use in the zoning district regulations.
- (b) Applicability; interpretation of schedule.
 - (1) When a particular activity group is shown as a permitted or permissible use within the use regulations of a zoning district, it shall be interpreted to mean any of the uses listed under that particular use activity group in this section, unless specifically noted to the contrary.
 - (2) When an individual use which is included within an activity group is listed specifically within the use regulations tables in Article V of this chapter, it shall be interpreted to mean apply to only that use, and shall not be interpreted to mean be inclusive of any other uses within the overriding activity group in which it is located.
 - (3) When a section, article or division number is indicated in parentheses following a particular activity, it is an indication that supplemental regulations affect the use, and the reader should refer to the indicated provisions.

- (4) When a number precedes or follows a use activity, it is a reference to the Standard Industrial Classification Manual, 1972 edition, and all uses listed within the SIC code are permitted unless specifically indicated to the contrary.
- (5)(4) Whenever a use group title includes the word "manufacturing," it shall be interpreted to also include repair of the type of product contained within the listing. However, this is not to be interpreted as requiring repair establishments to be placed within one of these use groups if:
 - a. No manufacturing is involved; and
 - b. The repair establishment qualifies under a different use activity group or defined term.
 - (5) Schedule of Uses approved as part of an existing Planned Development prior to September 1, 2016 are subject to the use activity group regulations as adopted at the time of PD approval.
- (c) Use activity groups are as follows:
 - (1) Apparel, manufacturing. Establishments whose primary function is the production of clothes, accessory items and other comparable textile, leather, and fur products.

- (1) New facilities of 50 or more beds, or the expansion of an existing facility that will bring the number of beds to 50 or more, or which changes the use, must request and be approved as a PD. See section 4-272 and Table 4-740.
- (2) Facilities proposed for ten or more acres or the expansion of an existing facility that will bring the number of acres to ten or more acres or that changes the use must request and be approved as a PD. See section 4-272 and Table 4-740.
- (3) Permitted only when clearly subordinate to the permitted use of the property and when conducted wholly within the principal building.
- (4) Noncommercial only.
- (5) If located within the Bonita Beach Road Corridor, this use permitted only by Planned Development (PD) zoning on parcels larger than one acre.

(6) New facilities of 16 or more beds, or the expansion of an existing facility that will bring the number of beds to 16 or more, or which changes the use, must request and be approved as a PD. See division 38 of this chapter.

- (2) If located within the U.S. 41 Overlay District, special exception approval required. See section 4-891.
- (3) Permitted only if completely enclosed within a building.
- (4) Establishments exceeding 40,000 square feet require PD zoning. See section 4-1560 et seq.
- (5) Limited to 500 square feet when in conjunction with one dwelling unit on the same premises.
- (6) Use only permitted when clearly incidental to a hotel or motel.

- (c) The following uses must be set back a minimum of 300 feet from any property under separate ownership zoned other than AG or IG. The setback applies to all buildings and structures, and all areas used for parking of trucks or equipment, shipping, receiving, or storage.
 - (1) Feedlots.
 - (2) Milk processing plants.
 - (3) Fertilizer mixing.
 - (4) Bulk chemical storage for crop dusting.
- (d) The following uses must be set back a minimum of 100 feet from any residentially zoned property under separate ownership. The setback applies to all buildings and structures, and all areas used for parking of trucks or equipment, shipping, receiving, or storage.
 - (1) Blacksmith shop.
 - (2) Freight and cargo handling establishments (section 4-408(c)(17)).
 - (3) Manufacturing of:
 - a. Boats.
 - b. Chemicals and allied products, Group II (section 4-408(c)(6)) Limited to cosmetics, perfumes, etc.).
 - Fabricated metal products, Group II (section 4-408(c)(14)).
 - d. Food and kindred products, Group II (section 4-408(c)(15)).
 - e. Furniture and fixtures (section 4-408(c)(18)).
 - f. Leather products, Group II (section 4-408(c)(24-23)).
 - g. Lumber and wood products, Group IVII (section 4-408(c)(25-24)).
 - h. Machinery, Groups I and II (section 4-408(c)(26-25)).
 - i. Paper and allied products, Groups II-and III (section 4-408(c)(30-29)).
 - Stone, clay, glass and concrete products, Groups I and III (section 4-408(c)(47-45)).
 - k. Textile mill products, Groups I and II (section 4-408(c)(49-47)).
 - I. Transportation equipment, Group II (section 4-408(c)(51-49)).
 - (4) Motion picture studio.
 - (5) Photofinishing laboratory (df).
 - (6) Rental or leasing establishment, Group IV (section 4-408(c)(38-36)).
 - (7) Repair shops, Group V (section 4-408(c)(39-37)).
 - (8) Social services, Group II (section 4-408(c)(45 43)).
- (e) Except when located in the C-2 district, the following uses must be setback a minimum of 100 feet from any residentially zoned property under separate ownership. If located in the C-2 district, the setback must be as required for other uses in the same district.
 - (1) Manufacturing of:
 - Apparel (section 4-408(c)(1)).
 - b. Electrical machinery and equipment (section 4-408(c)(11)).
 - c. Fabricated metal products, Group III (section 4-408(c)(14)).
 - d. Food and kindred products, Group III (section 4-408(c)(15)).

- e. Lumber and wood products, Group II (section 4-408(c)(2524)).
- f. Measuring, analyzing, and controlling instruments (section 4-408(c)(2726)).
- g. Novelties, jewelry, toys, signs, Groups I, and II, and III (section 4-408(c)(2827)).
- h. Rubber, and plastics, and fiberglass products, Group II (section 4-408(c)(4341)).
- (f) The minimum setbacks set forth in subsections (a), (b), (d), and (e) of this section are not applicable to those facilities legally in existence and operation, or to an industrial subdivision legally in existence, prior to a residential zoning or use being approved closer than the required setbacks.

Sec. 4-2095. - Subordinate uses.

- (a) *Purpose*. The purpose of this section is to provide for certain commercial uses; provided such uses are clearly subordinate to a permitted principal use and are in compliance with the regulations set forth in this section.
- (b) Subordinate commercial uses for mobile home or recreational vehicle developments.
 - (1) The following uses, lawfully existing, are permitted uses provided they are in compliance with the regulations set forth in this section. Uses established subsequent to August 1, 1986, may be permitted only by special exception except when approved as part of an MHPD or RVPD.
 - a. Food store Group I (section 4-408(c)(16)).
 - b. Laundromat.
 - c. Personal services Group I (section 4-408(c)(3231)).
 - d. Specialty retail store Groups I and II (section 4-408(c)(46-44)).
 - e. Real estate office for sale or rental of units within the development only.
 - f. Parts and supplies for mobile homes or recreational vehicles.
 - (2) All uses, except the real estate office, must be located within a permanent building which complies with the state building code. The total land area for the uses listed in this subsection may not exceed ten percent of the total land area of the development.
- (c) Other subordinate commercial uses.
 - (1) The subsection applies to subordinate commercial uses for hotels/motels, multiple-family buildings, social services Groups III and IV (section 4-408(c)(45-43)), health care facilities Groups II, III and IV (section 4-408(c)(19)), cultural facilities (section 4-408(c)(10)), and office complexes containing 50,000 square feet or more of floor area on the same premises. The uses listed in subsection (c)(2) of this section will be permitted when clearly subordinate to the principal use, subject to the following requirements:
 - The retail use must be totally within the building housing the principal use;
 - The retail use may not occupy more than ten percent of the total floor area of the principal use; and
 - Public access to the commercial uses must not be evident from any abutting street.
 - (2) Uses permitted are:
 - a. Personal services Groups I and II (section 4-408(c)(-32 31)).
 - b. Pharmacy.
 - Specialty retail store Groups I and II (section 4-408(c)(-46-44)).
 - d. Restaurant Group II (section 4-408(c)(43 40)).

e. Rental or leasing establishment Group I (section 4-408(c)(-38-36)).

Sec. 4-2191. - Purpose.

The purpose of this division is to provide regulations for social service, Groups III through V, as outlined in section 4-408(c)(45-43). These regulations recognize that it is in the public interest to provide diverse and accessible social services to people who would otherwise not receive it, and to ensure that standards of public health and safety are maintained. The regulations are intended to reduce conflicts between these and other uses in recognition of the potential land use impacts.

SECTION THREE: CONFLICTS

Whenever the requirements or provisions of this amending ordinance are in conflict with the requirements or provisions of any other lawfully adopted ordinance or statutes, the most restrictive requirements shall apply.

SECTION FOUR: SEVERABILITY

If any part, section, subsection, or other portion of this Ordinance or any application thereof to any person or circumstance is declared void, unconstitutional or invalid for any reasons, such part, section, subsection, or other portion of the prescribed application thereof, shall be severable, and the remaining provisions of this Ordinance, and all applications thereof not having been declared void, unconstitutional or invalid, shall remain in full force and effect. The City declares that no invalid or prescribed provision or application was an inducement to the enactment of this Ordinance, and that it would have enacted this Ordinance regardless of the invalid or prescribed provision application.

SECTION FIVE: CODIFICATION, INCLUSION IN CODE & SCRIVENER'S ERRORS

It is the intention of the City Council for the City of Bonita Springs that the provisions of this Ordinance shall become and be made part of the Bonita Springs Land Development Code; and that sections of this ordinance may be renumbered or re-lettered and that the word "ordinance" may be changed to "section," "article," or such other appropriate word or phrase in order to accomplish such intention; and regardless of whether such inclusion in the code is accomplished, sections of this ordinance may be renumbered or re-lettered and typographical errors which do not affect the intent may be authorized by the City Manager, or the City Manager's designee, without need or public hearing, by filing a corrected or recodified copy of same with the City Clerk.

SECTION SIX: EFFECTIVE DATE

The effective date of this ordinance shall be thirty (30) days from its adoption date.
