IV. ROLL CALL:

Mayor Simmons and all Council Members were in attendance.

V. PUBLIC COMMENT ON AGENDA ITEMS

9:03:29 am Rick Steinmeyer reminded everyone of the Lion's Club fish fry. He also commented on the Wonder Gardens loan.

9:04:11 am Kathy McGrath reminded everyone that Celebrate Bonita will be March 25, 2017.

9:05:32 AM Bonnie Wittimore, President of the Bonita Springs Historical Society, addressed City Attorney's Item XII. A., regarding the demolition delay ordinance.

9:58:33 am Dennis Gilkey, on the Board for the Wonder Gardens, stated that he would like an acknowledgement from the Board that the \$1 million payment due on June 1, 2017 is not going to happen, as it's not feasible for where they are at. He further explained. Council Member Quaremba stated she supports the Wonder Gardens flourishing, but needs more time as there are still a lot of questions.

10:14:02 am Council Member O'Flinn stated that the premise of the entire conversation here is that everyone on Council is committed to making the Wonder Gardens fully flourish. Council agreed. Council Member O'Flinn next motioned that this Council is committed to seeing Wonder Gardens fully flourish and that toward that end, among the matters that will be considered is the possibility of a loan extension. His feeling is that this would put the public and the Wonder Gardens on clear notice that City Council is committed to that.

City Attorney Vance furnished a brief overview, referring to Florida Statutes Chapter 166 which requires that a Charter Review Committee be formed to meet at least every ten years, after the dissolution of the previous committee. Discussion followed on potential referendum items. City Attorney Vance requested Council inform her of any items they would like her to look at. Council direction to not establish a Charter Review Committee, and to look at the issues discussed and City Council can determine if they want to add them to a ballot currently, or look at it for 2020 – look at the research first before they figure that out.

11:36:37 am City Manager Schwing reported that the art festival held this past weekend went very well with Old 41 Road open. He thanked Lora and her team for her hard work on that as well as Council Member Gibson and the Sheriff's Office for their work in making the event happen safely with Old 41 Road open. He next furnished an update on downtown and the one way bridge over the Imperial River, reporting that work on the bridge was on schedule for being completed in two weeks. Lastly, he addressed an incident that occurred at Bernwood and Old 41 involving an accident that occurred at the signal.

11:44:00 am Council Member Quaremba informed Council that she also attended the art show and that it seemed to work well. She was able to cross, park and get around. She thinks the new procedure worked very well.

11:44:10 am Council Member Slachta informed Council of a neighbor of his who can't wait for the pickleball courts to be done. He asked Parks and Recreation Director Nicole Perino when they were scheduled to open. Ms. Perino reported that the YMCA hasn't provided a timeline on construction, but they are moving currently moving dirt. The hope is by March, but she doesn't have an exact deadline.

11:44:46 am Council Member O'Flinn thanked Council Member Forbes, as he (Council Member O'Flinn) attended the ECCL meeting as Council Member Forbes spoke about Edison Farms and expressed the view of City Council very clearly and thoughts relating the importance of it being "in perpetuity" and the importance of including all six sections. He also furnished an update on City Council's Joint Meeting with the Village of Estero which has been scheduled for February 28, 2017.

11:50:22 am Council Member Gibson thanked the Art League and Staff for their work in keeping the road open, which did seem to work out very well, with the only hindrance still being the bridge with it being one lane, which should be worked out in a couple weeks. He also apologized to the Art League if he misstated at Council's last meeting that they were asked to leave, as his main point was that they're not there anymore. He also did not believe it addressed any specific event on Fifth Avenue, as for future events they did ask that the Council place limits on road closures for Fifth Avenue. Lastly, he questioned the status of the light at Bonita Bay and Limetree, which City Manager Schwing responded they were on track for April. The long wait time is a result of the posts and equipment have to be manufactured custom for each individual intersection. Currently, they are still in the manufacturing stage, adding that once they get the equipment it won't take that long to get it up.

City Manager Schwing explained that the City is not involved in that intersection, as it's being handled by the private sector, and therefore, he does not have an update on that intersection.
