Discussion was held on city-initiated rezoning, or have them go through a process privately. John Dulmer, Community Development, stated he would recommend allowing Community Development work with them with application to come from their community. He can come back with

more information to Council. Council Member O'Flinn addressed the need for a consensus from the neighborhood. Discussion was held with them getting a consensus from their neighborhood first.
