My name is Frances Mourad, and I reside at 12737 Hunters Ridge Drive.

I am writing regarding the proposed 150-foot wireless tower in Hunters Ridge. While I understand there has been community support for a tower, my concern is specifically with the **proposed location**.

Placing a structure of this height in close proximity to existing homes concentrates the visual and potential property impacts on a small number of residents. This creates a disproportionate burden that is not shared equally across the community.

This is not simply a question of whether a tower should be built, but whether this is the most appropriate placement given its direct impact on nearby homes.

For the record, I am also submitting a prior petition (in 2 parts) reflecting resident concerns regarding the location of the tower.

I respectfully ask that the Council consider whether adjustments to the placement, or appropriate conditions, could reduce this impact.
